It may be noted that the fellowship amount shall be disbursed through Central Bank to bank account of the Awardee (any bank directly). UGC has developed a dedicated web portal ([www.ugcnet.ac.in](http://www.ugcnet.ac.in)) for capturing data of the awardee. The Universities/Colleges/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Master/Checker Ids which have already been provided to them along with the portal. The Universities/Colleges/Institutions shall update the information in the master data regarding monthly payment confirmation, MRA, up-gradation, resignation etc., of the beneficiary on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Colleges/Institutions, the payment of the fellowship will be made to the beneficiary (Detailed process available at <http://www.ugc.ac.in/ugcnet/section.asp?id=2133>).

It may also be noted that UGC has proposed to link "A4BHE4B" with bank account of students so that they can be direct cash transfer and effective disbursement of fellowship into bank account of the student. In this regard, Secretary, UGC has already requested the universities to help students in Aadhaar enrollment vide D.O. No. F.16-10/2011 (CPP-II) dated 11.01.2013.

The candidate must fulfil the minimum eligibility conditions for SET as laid down in the notification for WBSET.
