The Act is a big step towards making the citizens informed about the activities of the Government.

## Implementation of 'The Right to Information Act, 2005' in the Universities / Colleges

The Right to Information Act, 2005 has come into force from 15 June, 2005. All Universities and Colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled or substantially financed directly or indirectly by funds provided by the Government come within the meaning of a Public Authority under this Act. In keeping with the requirements of the Act and its provisions, the RTI Cell of the **Siddhinath Mahavidyalaya** was constituted in the academic session 2018-19 under the University guidelines.
