The feedbacks received are analyzed and necessary action is taken through proper channel. With regard to feedback on curriculum, academic performance of teachers and ambience of the institution following actions have been taken by IQAC after relevant discussion in IQAC. The action taken report has been handed over to Govering body for their approval.

- During lockdown/pandemic period more ICT-oriented and digital learning system is focused.
- Teachers are requested to take more online classes abinding the departmental routine during lockdown. After partial opening of college, they have taken classes in blended mode.
- Teachers have been asked to upload more study materials/learing modalities for uploading in LMS for easy access of students.
- Teachers have regularly communicated students through WhatsApp groups. Notifications from affiliating university regarding syllabus reduction, internal and final exams are regularly shared with students.
- Emphasis given on arranging counselling programmes to eradicate the trauma of students affected by pandemic.
- The departments have to organise student seminars.
- Departments have already organised webinars/ workshops/ invited talks using online platforms. They are encouraged to do the same in future.
- Teachers and students are encouraged to participate in online lectures, webinars etc. to strengthen their academic knowledge and expertise.
- Remedial claases have been taken during pandemic for slow learners.
- Books and magazines have already been purchased for Central library. More to be procured.
- Library user orientation programme has been organsied.
- Besides, the Principal after discussing with Governing Body members asked all faculties to address the issue of maintaining COVID protocol within the campus after getting the circular of college reopening in the month of November 2021.
